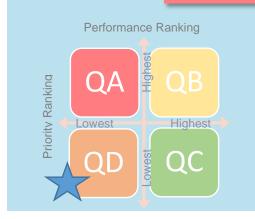

Model Standards

Model Standards represent the major components or practice areas of the Essential Service. Standards 8.1 & 8.3 scored as **MODERATE**, 8.2 **SIGNIFICANT**, and 8.4 as **MINIMAL** activity.

Several participants indicated that:

- Their organizations provide significant amounts of training and career development for employees
- They were aware of several healthcare profession workforce assessments, and use these assessments to improve their organizational workforce

A few participants noted that:

 Many healthcare professions are highly regulated with stringent workforce standards

PERCEIVED SYSTEM WEAKNESSES:

Several participants indicated that:

 There may be silos of information within the system preventing improvements in the workforce

A few participants noted that:

- They were aware of several healthcare professional workforce shortage areas including dentistry, nursing, and specialty healthcare providers.
- Many healthcare professions are highly regulated and require significant investment in continuing education
- A retiring healthcare professional workforce could lead to additional shortage areas.

PERCEIVED SYSTEM OPPORTUNITIES:

Participants suggested the following for optimization of this essential service:

- Promotion of public health as a career choice
- Formalization of public health competencies through certification
- More coordination of workforce improvement activities between organizations within the public health system
- Integration of healthcare workforce assessment data

Best practice/innovative approaches highlighted:

- Community Healthcare Worker Coalition mentoring program
- University of South Florida online undergraduate Public Health Program
- Hospital healthcare professional scholarship programs and incentives

Essential Service #8 decreased in performance and was ranked with a priority, as compared to the 2012 local public health system assessment.
